### MARK BRITNELL

Global Healthcare Expert and Vice-Chairman, KPMG (United Kingdom)

Mark Britnell is one of the foremost global experts on healthcare systems, dedicating his entire professional life to healthcare, having led organizations at local, regional, national, and international levels. He has worked in more than 80 countries, gaining a unique first-hand experience.

In 2000, Mark was appointed Chief Executive of University Hospitals Birmingham, where he masterminded the largest new hospital build in NHS history, established the Royal Centre for Defence Medicine, and developed one of the highest

performing healthcare organizations in the United Kingdom. He went on to run the NHS South Central region before joining the NHS Management Board as a director general at the Department of Health, where he developed the "High Quality Care for All" with Lord Darzi of Denham.

Mark was KPMG International's Global Head of Infrastructure, Government and Healthcare from 2009, returning to the KPMG UK partnership in 2020. He is a member of the Global Agenda Council on the Future of the Health Sector for the World Economic Forum and sits on the Advisory Board of the China Center for Health Development at Peking University. Mark is also a Visiting Professor at UCL's Global Business School for Health.

Mark is the author of the award-winning book In Search of the Perfect Health System, where he puts 25 healthcare systems under the microscope. His second book, Human: Solving the Global Workforce Crisis in Healthcare, published in 2019, examines how the health worker shortage issue has and will continue to impact some of the world's leading health systems, while boldly offering 10 concrete and actionable solutions to help navigate the looming deficit.

Analyst, Czech National Bank Distance Learning Program Main Instructor (Health **Economics, Labor Economics)** 

Eva Hromadkova is an Expert Analyst of the Economy at the Czech National Bank, the Monetary and Statistics Department since 2011. She received her Ph.D. from CERGE-EI, spending more than a year of her studies as a visiting researcher at the

National Bureau of Economic Research in New York. Between 2017 and 2022, she served as Program Director of the Master's in Applied Economics Program at CERGE-EI. Ms. Hromadkova's research has concentrated on health care systems, in her work she focuses on analyses of household behavior and firm credit. She has taught a variety of subjects, including health economics, labor economics, and advanced macroeconomics.
